Data Protection Policy

In the context of the preparation and implementation as well as follow-up of the event "Mozilla Rise 25 Award", an event of Mozilla Foundation, the data processing is carried out by LA MAISON Victor Schilly & Friends GmbH, in accordance with the European Data Protection Regulation (DSGVO), the Federal Data Protection Act (BDSG).

To comply with our duty to inform you about the data processing as well as your rights (Art. 13 and 14 DSGVO), please find below information about the processing of your personal data when using our website and when contacting us via e-mail, telephone or postal mail.

1. Basics

1.1 Person responsible and data protection officer

1.2 Personal data

Personal data is any information relating to an identified or identifiable individual. An identifiable individual is a person, who can be identified directly or indirectly - in particular by means of an association with an identifier such as a name, an identification number, location data, an online identifier (Art. 4 No. 1 DSGVO).

1.2 Legal basis of the processing

We process your personal data on the basis of

- Art. 6 para. 1 lit. a) DSGVO, if you have consented to the processing,

- Art. 6 para. 1 lit. b) DSGVO, if the processing is necessary for the performance of a contract or pre-contractual measures,

- Art. 6 para. 1 lit. c) DSGVO, if the processing is necessary for the fulfillment of a legal obligation imposed on us,

- Art. 6 para. 1 lit. e) DSGVO in conjunction with. § 3 BDSG, if the processing is necessary for the performance of a task assigned to us in the public interest or in the exercise of official authority (e.g. answering contact requests).

2. Data processing in relation to accreditation

Accreditation to the Mozilla Rise 25 Award event requires the collection of personal data. The mandatory information is your first and last name, e-mail address, telephone number, company name and function. The provision of further personal data, such as address data is optional.

For the preparation, implementation and follow-up of the event, your data will be stored on secure servers operated by LA MAISON Victor Schilly & Friends GmbH.

In addition, the e-mail address details from the accreditation system will be used for further processing in the context of the Mozilla Rise 25 Award event. This is a password-protected participant area. In addition, your personal details may be forwarded to Mozilla Foundation upon request. After usage, the collected data will be deleted.

3. Photo and video documentation of the event

LA MAISON Victor Schilly & Friends GmbH process personal data for the organization of events in accordance with the privacy policy available on the Internet https://lamaison-vsf.com/datenschutz/. Photos, videos and metadata are processed by LA MAISON Victor Schilly & Friends GmbH and Mozilla Foundation for photo/film documentation and reporting and publication in electronic and print media (e.g. websites and blogs, social networks, newsletters, information brochures, press releases, image databases, television, press publications). Personal data is stored until the purpose of use is no longer applicable, unless longer retention periods are prescribed by law.

4. Processing of personal data when contacting us

When contacting us, the data you provide (your name, e-mail address) as well as the content-related information transmitted (personal data, if applicable) will be processed for the purpose of contacting you and handling your request and stored in accordance with the time limits applicable to the storage of written documents as set out in the Registrar's Guideline, which supplements the Joint Rules of Procedure of the Federal Ministries (GGO). The retention periods are generally 10 years, in exceptional cases up to 30 years.

If we are not responsible for your request, it may be forwarded to Mozilla Foundation without your consent, while maintaining data protection, if it can be assumed that the forwarding for the purpose of responding is in your interest and no sensitive personal data is involved (Art. 6 Para. 1 lit. e) DSGVO in conjunction with § 3 BDSG, § 25 Para. 1 in conjunction with § 23 Para. 1 No. 1 BDSG).

5. Your rights

5.1 You have the following rights vis-à-vis us, regarding the personal data concerning you:

- Right to information, Art. 15 DSGVO
- Right to rectification, Art. 16 DSGVO
- Right to erasure ("right to be forgotten"), Art. 17 DSGVO
- Right to restriction of processing, Art. 18 DSGVO
- Right to data portability, Art. 20 DSGVO
- Right to object to processing, Art. 21 DSGVO

5.2 Right to Revoke

If the processing of your personal data is based on your consent, you have the right to revoke this consent at any time without giving reasons. The revocation of consent does not affect the lawfulness of the processing carried out on the basis of the consent until the revocation (Article 7 (3) DSGVO).
